Commencement

ENACTED by the National Assembly of the Federal Republic of Nigeria:

1. The Laws of the Federation of Nigeria compiled and published in 2004 under the authority of the Atterney-General of the Federation and Minister of Justice are hereby approved by the National Assembly.

Approval of the Revised Edition of the LFN 2004.

2. Any inadvertent omission, alteration or amendment of any existing statute shall not affect the validity and applicability of the statute.

Existing statutes unaffected by the inadvertent omission, etc.

3. The Revised Edition (Laws of the Federation of Nigeria) Act 1990 is repealed.

Repeal,

4. In this Act-

"existing statutes" means any enactment, subsidiary instrument, legislation in force before the giving of effect to the provisions of this Act.

Interpreta-

5. This Act may be cited as the Revised Edition (Laws of the Federation of Nigeria) Act, 2007.
